#### Context:

# **Investment & Asset Management:**

IBA's Investments aims to create economic independence for Aboriginal and Torres Strait Islander peoples by using its capital base, skills and expertise, to build and manage a substantial portfolio of investments and generate economic impact for Indigenous Australians via financial returns, commercial capability development, employment, training and supply chain outcomes.

IBA has a long history of over 20 years of successful investment alongside Indigenous organisations. The portfolio comprises over \$480 million in investments across Australia in a variety of sectors, including tourism, property, funds management, energy, primary industries, industrial and retail businesses.

## Role:

Primary responsibilities are:

- To ensure that Investment and Asset Management is effectively supported through the provision of program strategy, policy and procedures development, budgeting and operational planning; business administration; portfolio and investment reporting and strategic and operational support.
- To support the Investment Managers in execution and management of investments including the preparation of financial models, undertaking due diligence, assisting with approvals etc.







#### **Duties:**

Duties include, but are not limited to:

#### **Business Analysis and Reporting**

Assist the Investments team, under the supervision and guidance of the Senior Analyst, Direct Investments, with:

- Preparing reports and conducting analysis to effectively communicate the investment portfolio performance to key stakeholders.
- Financial modelling and scenario analysis.
- Delivering standardised reporting to internal and external stakeholders in order to manage investee company performance.
- Liaise with IBA's Finance Team to aligning IBA reporting requirements and other needs including reconciliation to IBA financial reporting systems.
- Managing the business administration functions of the Investments team including planning, budgeting, tracking and reporting on variances between actual and budgeted figures.
- Facilitating the development and continuous improvement of the business through providing specialist advice in relation to business processes, systems, management accounting and portfolio and investment level reporting.
- Undertaking external stakeholder engagement, including preparation of relevant correspondence
  for the Parliamentary Questions and Ministerial representations, briefing reports and preparation
  of papers for the Board, Executive and senior management, and internal and statutory reporting
  compliance.
- Contributing to the prudent risk management of investments to ensure that financial and reputation risks to IBA are managed appropriately, including by participating in IBA portfolio review processes.
- Driving and implementing continuous improvement across investment valuations, portfolio monitoring and impact measurement and reporting.
- Managing the annual valuation process for IBA's investments.
- Working with the Senior Analyst and other team members to update / improve the intranet site for Direct Investments.
- Other duties as required.

# **Investment Related**

- Undertaking market and terrain research and analysis.
- Thorough, accurate and timely financial analysis.
- Assisting in:
  - development of portfolio strategy;
  - building best practice financial models;
  - undertaking investment evaluations based on the IBA's criteria;
  - sourcing and identification of potential investment opportunities;
  - performing detailed due diligence;
  - formulating and executing of investment strategy including exit, turnaround / restructuring and growth strategies;
  - estimating potential investment equity returns, employment and procurement impacts;
  - preparing and presenting high-quality papers / presentations;
  - o overseeing preparation and review of legal documentation;
  - deal structuring and execution; and
  - o integration of new investments into the portfolio.

- Assist Investment Managers with the ongoing management of investments including:
  - Monitoring, managing and reporting performance.
  - Responding to information requests.
  - Managing divestments and dividend distributions.
- Assist in driving and implementing continuous improvement.
- Other duties as required.
